PS: Havo issues this statement in respect of Module A of Self certification of the EU framework on the marketing of products (2008/768). After a thorough assessment of raw materials, a safety assessment, technical documentation, internal production control (HAVO is a certified ISO 9001 company) and conscious periodically testing of some products at authorized labs, we issue this statement.

Test reports:

Vegan and our own claim "98% natural ingredients" are not backed by external certificates as an external vegan certificate is preferably for food and requires an unrealistic investment.
